Background

The Land Development Agency is committed to supporting a responsible and ethical organisational culture within the Agency. This Agency takes its obligations under the Protected Disclosures (Amendment) Act 2022 very seriously and is strongly committed to supporting people to speak up about their concerns of wrongdoing, as defined in the legislation.

As required under the relevant legislation, the Agency has a Protected Disclosures Policy in place under which a staff member¹ who wishes to make a protected disclosure may do so. Contact details for the confidential internal recipients, as well as procedures for making a protected disclosure, are contained in the policy document which has been circulated to all staff through the Agency's intranet, and which is also available on the Agency's [website](#). At all times, it is central to this Agency's protected disclosures policy that the reporting person's identity will be treated confidentially in accordance with the Protected Disclosures Act 2014 as amended by the Protected Disclosures (Amendment) Act 2022.

Annual Report for year ending 31st December 2025

Section 22 of the Protected Disclosures Act requires public bodies to prepare a report each year setting out the number of protected disclosures made to it in the course of the immediately preceding year and the action taken (if any) and certain other information relating to any such protected disclosures.
