Dear

I refer to your request, dated and received on 30th November 2021, which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by the Land Development Agency (LDA).

- a database/spreadsheet/record of all purchase orders/payments in excess of €10,000 for the calendar year 2020 and thus far in 2021.

I wish to inform you that I have decided to grant your request on the 6th January 2022.

The purpose of this letter is to explain that decision.

Details of your request were provided to the relevant sections within the LDA to identify records held which were within the scope of your request.

2. Right of Appeal

The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this body.
